When the weapon is not alleged to have been used in any way in the crime charged against the defendant, the government must establish a proper foundation, however, for it to be admitted under Rule 404(b). Id. 33 Here, the weapon is relevant for the purpose of showing that the conspiracy existed. There was no error in admitting this evidence of the previous robbery in this case. V. 34 Mr. Fason's final argument is that the district court erred in enhancing his sentence under the Sentencing Guidelines based on a finding that the robbery involved a "dangerous weapon," and in basing the sentence enhancement on the fact that the assault on Mr. Fason was especially heinous, cruel, or brutal. 35 We need not decide whether the district court erred in applying either of the Sentencing Guidelines enhancements, because we are reversing the conviction on other grounds. Torres*, 53 F.3d 1129, 1138 (10th Cir. 1995), we held that "the failure to object to a sentencing enhancement before the district court constitutes a waiver of that issue unless the error is plain under existing law."
